

VILLAGE OF WATERMAN LIQUOR LICENSE APPLICATION

If / when a police officer is employed on duty, and on location of a liquor license establishment in the Village of Waterman, that same officer can order any employee, volunteer, agent or liquor license holder to take a breath test if the police officer suspects the above employee, volunteer, agent or liquor license holder to be under the influence of alcoholic liquor. Failure to follow the above order by police shall result in a violation of license to sell alcohol in the Village of Waterman.

Any violations of the provisions and terms of this application can result in suspension or termination of a liquor license. The liquor license holder will be granted a hearing through the same procedures now in effect for violations in Intoxicating Liquor Section, in the Waterman Village Code.
